ACCESS ARRANGEMENTS AND REASONABLE ADJUSTMENTS (AARA)

Students that have disability, impairment and/or medical conditions may be eligible for AARA. Eligibility for AARA falls within three main categories:

- **long-term and chronic conditions** (e.g. hearing or vision impairment, intellectual disability, physical impairment, dyslexia, attention deficit disorder, autism spectrum disorder, diabetes)
- **short-term conditions**, which may improve or deteriorate over time depending on a range of factors (e.g. anxiety and depression), and temporary injuries (e.g. broken limb)
- **illness** (e.g. measles) and misadventure (e.g. flooding, death of a close family member).

Some common adjustments that can be made for students include:

- Extra time (five minutes for every 30 minutes of working time) for examinations
- Varied seating – own room, small group supervision
- Rest breaks
- Assistive technology
- Food snacks (diabetes or similar conditions)
- Extensions to assignments

All AARA must be applied for by parents/caregivers. It is not an automatic process even if the student has received adjustments in earlier years of schooling.

To apply for AARA, email Assistant Principal: Brenda Mallory (brenda.mallory@tccr.com.au) and you will be sent the necessary documents. The Learning Support Department will also be involved in the application process and will provide historical information of previous adjustments provided.
